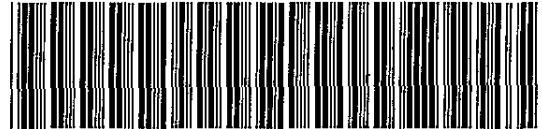



ARTICLES OF INCORPORATION

OF
