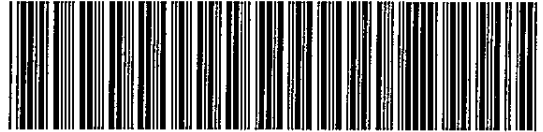

ARTICLES OF INCORPORATION

OF

WE, THE UNDERSIGNED, being natural person(s) of legal age, hereby desire to form a corporation under the laws of the state of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be T&D FINISHING TOUCHES, INC., a Florida corporation. The initial principal place of business of this corporation shall be 2592 Sedgefield Avenue, Deltona, Florida 32725 and its mailing address shall be 2592 Sedgefield Avenue, Deltona, Florida 32725.

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation shall have those powers authorized or permitted by law or otherwise, it being the intention that this corporation shall have the right to engage in any business or activity not expressly prohibited by applicable law of the state of Florida.

CAPITAL STOCK

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director, officer, employee or agent may be entitled.

ARTICLE IX

AMENDMENT

The corporation reserves the right to amend, alter, change, repeal and revise any of the provisions of this corporation's Articles of Incorporation in the manner now, or hereafter prescribed by statute and all rights conferred on shareholders herein are granted subject to this reservation.

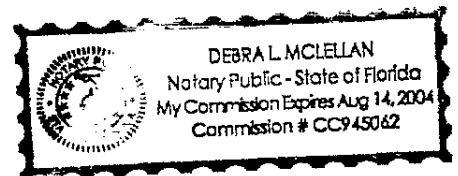


