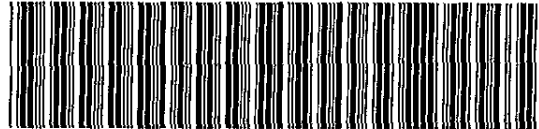

ARTICLE I

The name of this corporation is: **SOUTHERN CABINETS INSTALLATION & INTERIOR TRIM, INC.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to provide interior carpentry trim services for residential and commercial structures and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK
