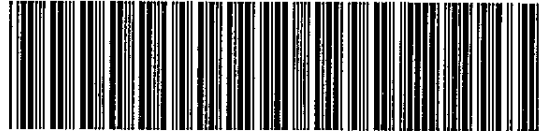

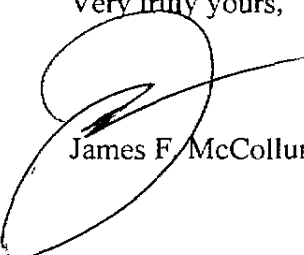

**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

- Article 1. NAME.** The name of the corporation is: NOONON ENTERPRISES, INC.
- Article 2. DURATION.** The duration of the corporation is perpetual.
- Article 3. PURPOSE.** The purpose for which the corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way and to do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.
- Article 4. CAPITAL STOCK.** The aggregate number of shares which the corporation is authorized to issue is 8,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
- Article 5. INITIAL PRINCIPAL OFFICE.** The principal address as well as the street address of the Initial Principal Office of the corporation is 524 Summit Drive, Sebring, FL 33870.
- Article 6. INITIAL REGISTERED AGENT & REGISTERED ADDRESS.** The name of the Initial Registered Agent is James F. McCollum, P.L. whose address is 129 South Commerce Avenue, Sebring, Florida, 33870.

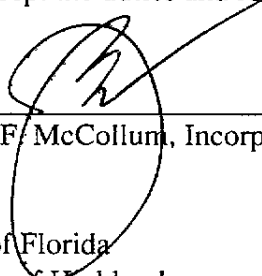

Article 10. ACCEPTANCE BY REGISTERED AGENT. I hereby am familiar with and accept the duties and responsibilities as registered agent for said corporation.

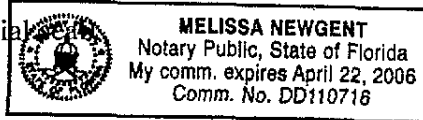
