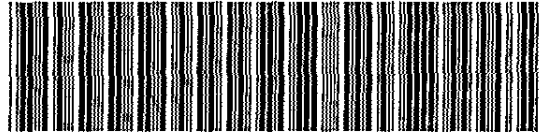


ARTICLE X
