On July 14, 2008, I filed my annual report online. The previous fee for this report filing was \$150.00. However, I was charged \$550.00 for this on-line filing. I made two separate calls to your help desk at (850) 245-6939 inquiring why the fee was so high and was told that the additional cost was a "late fee". The help desk personnel also stated that this late fee notice was visible when the report was filed. At no time during the transaction was this the case. I completed the transaction because I believed that this higher amount was the result of higher fees related to lowering of the property tax and not a late fee. Additionally, I never received a reminder to file the Annual Report in April, 2008. When a notice of intent to dissolve came in July, 2008 I did not hesitate to file not realizing the cost was \$550.00

On the advice of your help desk, I am writing this letter to request a refund of the \$400.00 late fee based on the above information.
