Dear Staff:

At your request (during a phone conversation) we have prepared this letter to explain our situation as it relates to Adventure Golf Creations & Construction Co. and Amazon River Golf & Expedition, Co. We submit the following for your consideration:

We filed for corporation status on the above two companies, but to date have not used them for any business activity. We have not filed for a Federal ID number and have not prepared any Federal tax returns. At the time we filed for the corporations we planned on starting a business using these names, but now we are not sure if that will happen. We want to hold the names for now in case we decide to use them in the future. We received the forms for the Annual Report, but because my wife was not informed on what we planned on doing she did not file the reports until May 26, 2004. The Notice of Intent to Dissolve was received and I just found out about it a couple of days ago. My wife sent in \$1650.00 for these two corporations and a third corporation we are using ($$550 \times 3 = 1650.00). I'm hoping you will consider waiving the penalties in this case because of confusions and only charge us the \$150.00 for each with a total of \$450 and return the \$1200 in penalties. We have a very tight budget and this extra cost is difficult. I have also sent back the two Annual Reports in question and marked the boxes for line 4 as not Applicable on both forms. We also hope you will not charge use the \$400.00 penalty for sending in these forms considering we do not have Federal ID numbers to put on the form.
