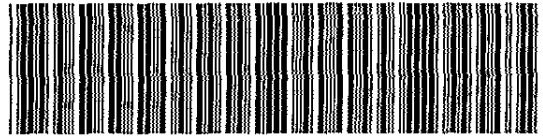

ARTICLE V


PRE-EMPTIVE RIGHTS

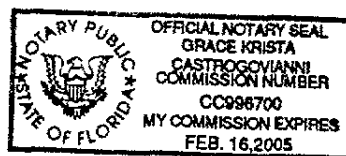
