# ARTICLES OF INCORPORATION OF AIR AMERICA AIRBOATS, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### Article I

The name of this corporation shall be AIR AMERICA AIRBOATS, INC.

#### Article II

The principal place of business and mailing address of the corporation is: 1215 South Otto Point, Inverness, FL 34450.

#### Article III

The general nature and purpose of business to be transacted, promoted and carried on by the corporation is as follows:

- 1. To engage in and provide airboat rides.
- 2. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

## Article IV


