ARTICLES OF INCORPORATION OF JOSE M. IGLESIAS, P.A.

The undersigned, who is duly licensed to practice public accounting in the State of Florida, for the purpose of forming a professional corporation under Chapter 607 of the Florida Statutes, Florida General Corporation Act and Chapter 621, Florida Professional Service Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the Corporation shall be JOSE M. IGLESIAS, P.A. (the "Corporation")

ARTICLE II PRINCIPAL OFFICE
