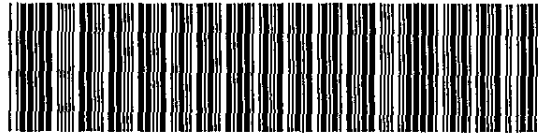

The name of this corporation is JIM JOHNSON CARPENTRY, INC.
