The undersigned subscriber to these articles of incorporation is a natural person competent to contract and hereby form a corporation for profit under chapter 607 of Florida Statutes.

### ARTICLE 1 Name

The name of the company is Satellite Academy, Inc., hereinafter referred to as the "Corporation."

#### ARTICLE 2 Purposes

The purpose of the Satellite Academy, Inc., is to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

#### ARTICLE 3 Principal Office and Registered Agent

- 5.4 The Board of Directors of the Professional Association may, by Restated Articles of incorporation, classify or reclassify any un-issued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of stock.
