# ARTICLES OF INCORPORATION OF JOHN CROSBY'S TRIM SERVICES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be:

JOHN CROSBY'S TRIM SERVICES, INC.

The principal place of business of this corporation shall be:
