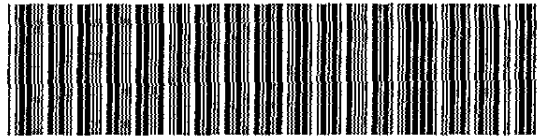

- FIRST:** The name of the corporation is SCANDASUN, INC.
- SECOND:** The period of its duration is Perpetual
- THIRD:** The purpose(s) for which the corporation is organized are "To operate a service company and any other lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes."
