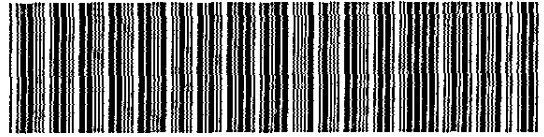

ARTICLES OF INCORPORATION  
OF  
RAINMAKER PLUMBING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is RAINMAKER PLUMBING, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The number of directors constituting the initial Board of Directors of the corporation is one (1). The name and address of the member of the initial Board of Directors is:

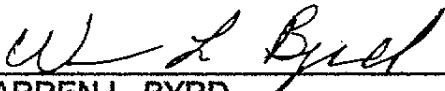
