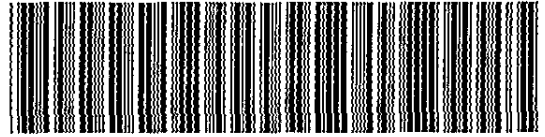

NAME OF CORPORATION

The name of the corporation shall be CARPET INSTALLATIONS BY PATRICK, INC.

ARTICLE II





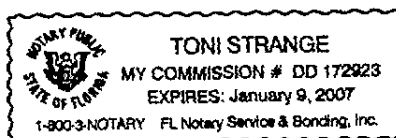
