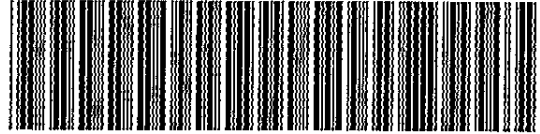

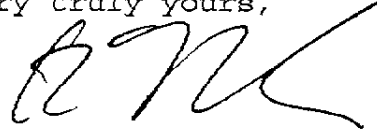

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name and principal office of the corporation is WEDABOSS SOLUTIONS, INC., 423 North Baylen Street, Pensacola, Florida 32501.

**ARTICLE II
DURATION**

The corporation will have a perpetual existence.

**ARTICLE III
PURPOSE**

The purpose of this corporation is to engage in any activities or business permitted under the law of the State of Florida.

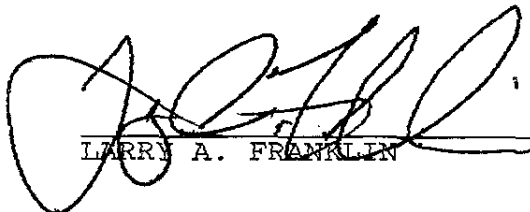

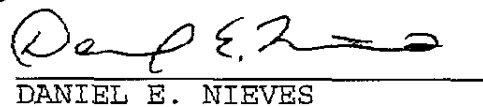

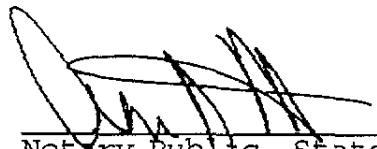
