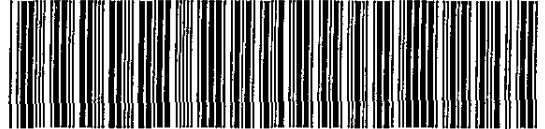



ARTICLE I


The name of the corporation shall be **DIACO OPPORTUNITIES, INC.**, effective on the date of filing.
