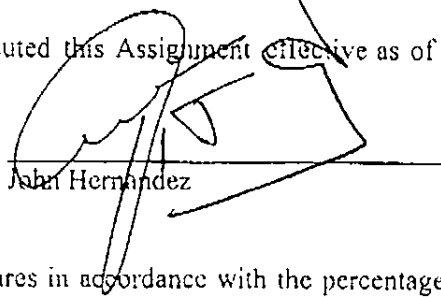
WHEREAS, Assignor desires to transfer, convey and all assign half of his respective Shares in the Corporation ("Shares") unto Assignee, as further provided below
