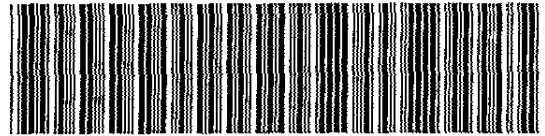

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is LUKE CONSTRUCTION, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 7385 A-1-A SOUTH, #B, ST. AUGUSTINE, FLORIDA 32080 (904)461-5447.

The name of the initial registered agent is JAMES LUKE SMITH III, who is familiar with and accepts of the duties and responsibilities as Registered Agent for said Corporation.

PRINCIPAL OFFICE AND ADDRESS is the same as the REGISTERED OFFICE.

PRINCIPAL OFFICE is the location where service of process can be accepted.

DURATION: The corporation shall have a perpetual existence.

ARTICLE VI



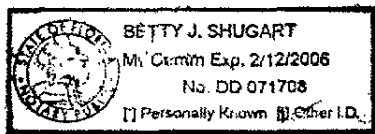
