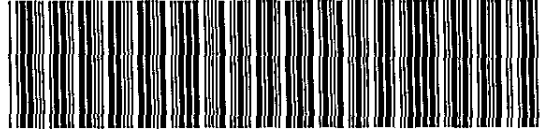

Duration and Commencement of Existence

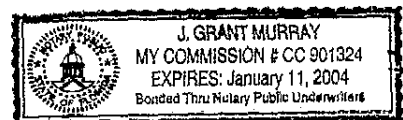

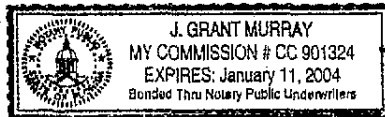
