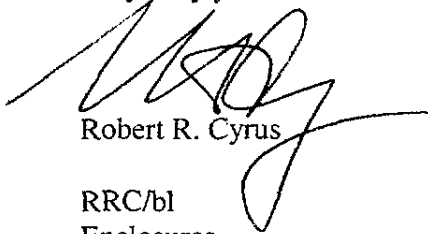

**ARTICLE I. NAME**

**EFFECTIVE DATE**

11-07-03

The name of this corporation is **GG3, INC.** The principal place of business is 1331 North First Street, Suite 705, Jacksonville Beach, Florida, 32250, and the mailing address is the same.

**ARTICLE II. DURATION**

This corporation shall begin its existence November 7, 2003.

**ARTICLE III. PURPOSE**

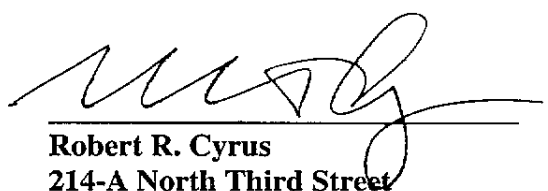
### ARTICLE IX. INDEMNIFICATION
