

NAME

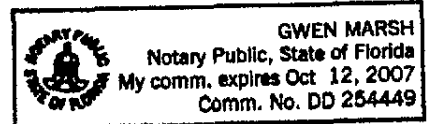

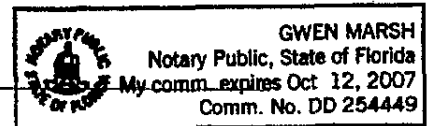
