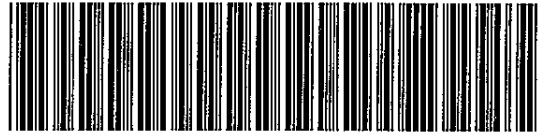


ARTICLE VIII
