

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation and the principal mailing address is:

ARTICLE II

The corporation may engage in any activity or business permitted under the law of the United States or of the State of Florida.




