ARTICLES OF INCORPORATION

OF

TUCKER DECORATIVE PAINTING, INC.



ARTICLE I - NAME

The name of the corporation shall be TUCKER DECORATIVE PAINTING, INC.

The mailing address for the corporation is 1834 Main Street, Sarasota, Florida 34236.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

ARTICLE X - REPLACING STOCK CERTIFICATES

The Board of Directors may, by resolution, provide for the issuance of stock certificates to replace lost or destroyed certificates.
