

#### ARTICLE I - NAME

The name of this corporation is Bob Knoll Construction, Inc..

#### **ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

#### **ARTICLE III - PURPOSE**

The nature of the business or purposes to be conducted or promoted are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.
