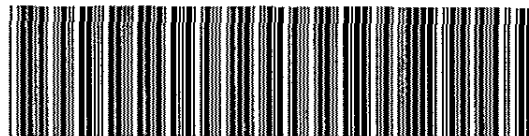

***BLANCHE CONSTRUCTION, INC.***




