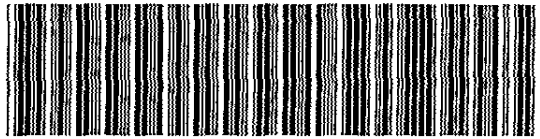

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: BONNIE HOFFMAN, INC.  
The principal place of business will be 2736 45<sup>TH</sup> Way N., St.  
Petersburg, FL 33713-3235.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT

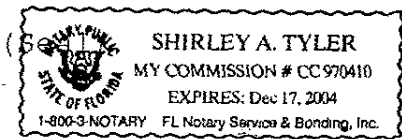
