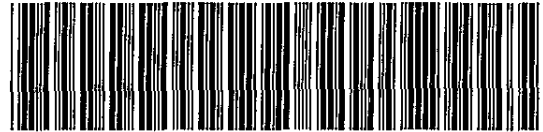

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: D.W. TURNER ROOFING, INC.

ARTICLE II

The existence of the Corporation shall begin on: FILING OF THESE ARTICLES OF INCORPORATION WITH THE SECRETARY OF STATE.

ARTICLE III

The street address of the principal office of the Corporation is: Sweetbriar Lane, Route 9, Box 38, Lake City, Florida 32024.

The mailing address of the Corporation is: Post Office Box 3307, Lake City, Florida 32056.

ARTICLE IV

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.




