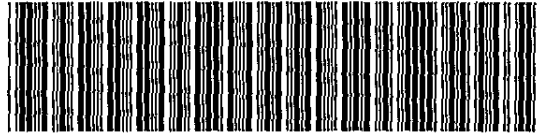

ARTICLES OF INCORPORATION

OF

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

1. **Name.** The name of this corporation is Chism's Concrete Pumping, Inc..




