**ARTICLE I. NAME**

The name of the corporation is Redland Brothers, Inc.

**ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE**

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

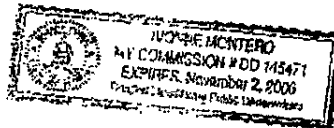
