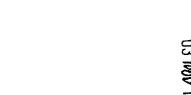

CAPITAL STOCK: The Corporation is authorized to issue only one class of stock. The total number of shares authorized shall be 500 and the par value is \$ 1.00

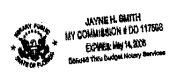
