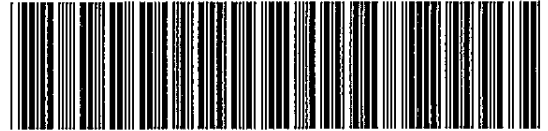

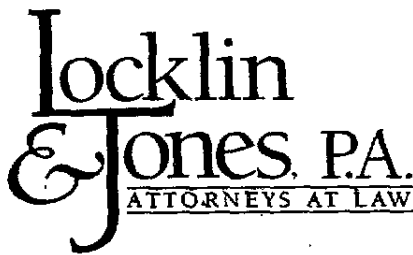

ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is: **WHITMAN SIDING, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.
