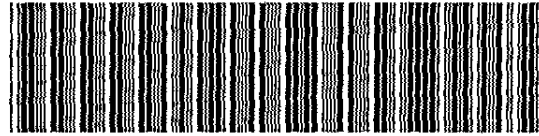

ARTICLE I

The name of this corporation is: **COTTON'S AIR CONDITIONING, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to provide air conditioning, heating, refrigeration and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK
