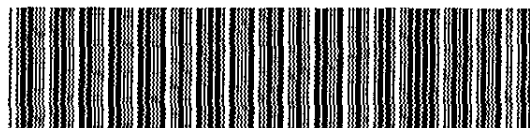

**ARTICLES OF INCORPORATION**

**BEDFORD TILE, INC.**

**ARTICLE I. NAME**

The name of the corporation shall Bedford Tile, Inc.

**ARTICLE II. ADDRESS**

The principal place of business and mailing address of the corporation shall be 7271 NE 91<sup>st</sup> Terrace, Bronson, FL 32621.

**ARTICLE III. DURATION**

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence on January 1, 2004.

**ARTICLE IV. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock on one class only, having a par value of \$1.00 per share.

**ARTICLE V. INITIAL REGISTERED AGENT AND STREET ADDRESS**
