ARTICLES OF INCORPORATION
OF
BRAWLEY MODULAR & MOBILE HOME SERVICES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME.

The name of this Corporation shall be BRAWLEY MODULAR & MOBILE HOME SERVICES, INC.

ARTICLE II. COMMENCEMENT & DURATION.

The existence of the Corporation will commence upon filing as provided by the laws of the State of Florida, and will continue thereafter perpetually.

ARTICLE III. PRINCIPAL OFFICE.

The principal place of business of this Corporation and its mailing address shall be 8160 Mantanzas, Road, Fort Myers, Florida 33912.

ARTICLE IV. NATURE OF BUSINESS.
