

ARTICLES OF INCORPORATION

Article I - Name

The name of the corporation is **Café Soleil, Inc.,** and the principal office and mailing address is 1\$\overline{\pi}\$\$ Baywood Avenue, Clearwater, Florida 33765.

Article II - Duration

This corporation shall exist perpetually.
