ARTICLE I. NAME

The name of the corporation shall be: Walker's Carpet, Inc. The principal place of business of this corporation shall be 15 Fluhart Street, Ormond Beach, FL 32174, and the mailing address of business shall be 15 Fluhart Street, Ormond Beach, FL 32174.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK
