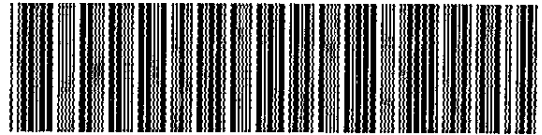

ARTICLES OF INCORPORATION

OF

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is CLINE'S STAMPED CONCRETE, INC.

DURATION

The term of existence of the corporation is perpetual.

PURPOSE

The purpose for which the corporation is organized is to install decorative concrete driveways, sidewalks and patios for profit.

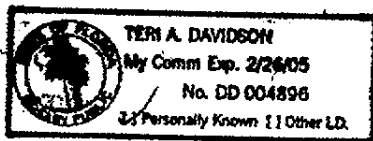
