**ARTICLE ONE


**ARTICLE EIGHT



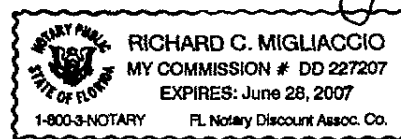
