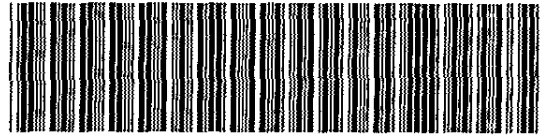

ARTICLES OF INCORPORATION  
OF  
TW Plasterers, Inc.

ARTICLES I - NAME

The name of the corporation shall be TW Plasterers, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of doing stucco and plastering contracting and for all other purposes as allowed under County, State and Federal laws.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares at \$5 par value of common stock.

ARTICLE IX - OFFICERS




