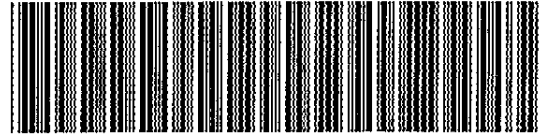

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is RESEARCH SERVICES OF PASCO, INC.

ARTICLE II - DURATION

This corporation shall exist into perpetuity.

ARTICLE III - NATURE OF BUSINESS

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to have 2500 shares of common stock at \$1.00 par value, which shall be designed "Common Shares" and is authorized to issue initially 500 shares at \$1.00 par value, which shall be fully paid for at the time of incorporation. Therefore, the initial capitalization of 500 shares shall be non-assessable.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - PRINCIPAL OFFICE

The principal office and mailing address of this corporation shall be located at 4218 Barker Drive, P.O. Box 524, Elfers, Florida, 34680-0524, but the corporation shall have the power to relocate its principal office or to establish branch offices at other places as may be determined and deemed expedient.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 4218 Barker Drive, P.O. Box 524 Elfers, Florida, 34680-0524, and the name of the initial registered agent of this corporation at that address is JOYCE FERREIRA.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

The power to adopt, alter, amend or repeal bylaws shall be vested in the shareholders.

ARTICLE XII - RESTRICTIONS ON TRANSFER OF STOCK

Shares of capital stock of this corporation shall be issued initially to the following persons and in the amounts set opposite their name.

ARTICLE XIII - CALLING OF SPECIAL MEETINGS

Special meetings of shareholders may be called by any stockholder owning not less than one-third of the shares.

ARTICLES XIV - MEETINGS BY CONFERENCE TELEPHONES

Members of the Board of Directors may participate in general or special meetings of the Board of Directors by means of conference telephone as provided by law.

ARTICLE XV - DIVIDENDS

Dividends may be paid to shareholders, both out of the earned surplus as well as from capital surplus as provided by law, with no restrictions included herein.

ARTICLE XVI - AMENDMENTS

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto; any right conferred upon the shareholders is subject to this reservation.

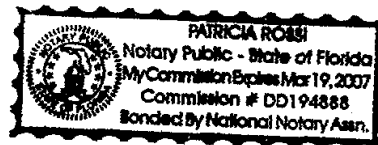
