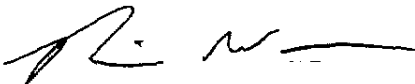

**ARTICLE I. NAME.**

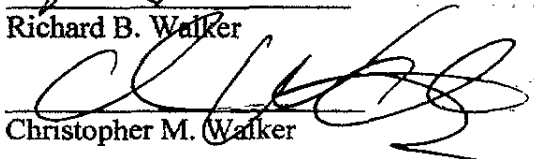
## ARTICLE X. AMENDMENTS

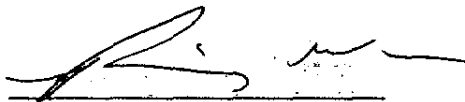

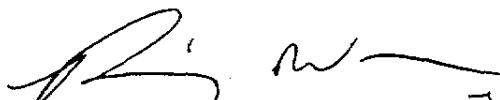
