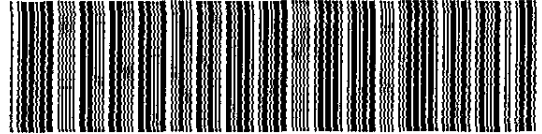

Articles of Incorporation of

Tonn A. Davis Painting, Inc.

The undersigned, for the purpose of forming a Corporation under Chapter 607, the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME: The name of the Corporation is: TONN A. DAVIS PAINTING, INC.

ARTICLE II: DURATION: The duration of the Corporation is perpetual.

ARTICLE III: ADDRESS: The street address of the office of the Corporation: 200 S. E. 10<sup>th</sup> Street, Carrabelle, FL 32322; the mailing address: P. O. Box 925 Carrabelle, FL 32322.
