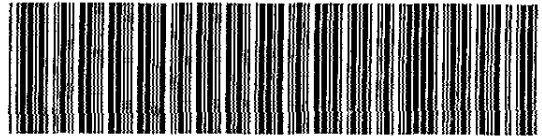

ARTICLE I. NAME

The name of the corporation shall be DIXON SEPTIC, INC.

ARTICLE II. ADDRESS

EFFECTIVE DATE
01-01-04

The principal place of business and mailing address of the corporation shall be 6490 SE 186TH Terrace, Morriston, FL 32668.

ARTICLE III. EFFECTIVE DATE

The effective date of the corporation shall be January 1, 2004.

ARTICLE IV. DURATION

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE V. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock on one class only, having a par value of \$1.00 per share.

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be by the Board of Directors, proposed by them to the shareholders, and approved at a shareholder's meeting by a majority of the shares entitled to vote thereon.
