**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be CANDLER HEATING & AIR CONDITIONING, INC., with its principal place of business at 10271 Southeast 110th Street Road, Belleview, Florida 34420.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

ARTICLE VIII - BY-LAWS

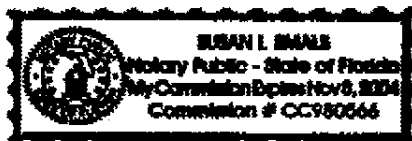
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.
