**ARTICLE VIII - BY-LAWS**

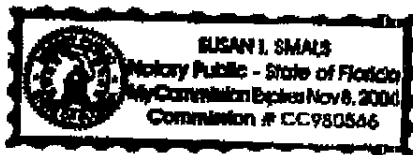
