The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE**Name**

- 1.1 The name of the Corporation is Pfeiffer Management Group, Inc.

ARTICLE TWO**Duration**

- 2.1 The term of existence of the Corporation is perpetual.

ARTICLE THREE**Purpose**

- 3.1 The purpose for which the Corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE FOUR**Stock**

- 4.1 The aggregate number of shares of stock that the Corporation has authority to issue is One Thousand (1000), all of which shall be common shares having a par value of One Dollar (\$1.00) per share. By signing these Articles of Incorporation, the registered agent accepts the designation and agrees to comply with the provisions of the Florida Statutes relating to that designation, including keeping the registered office open during the appointed hours of operation.

- 7.1 The Corporation shall commence its existence on the filing of these Articles of Incorporation.




