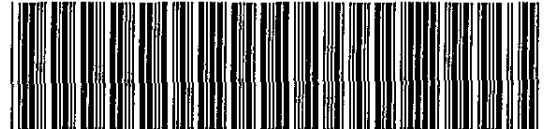

ARTICLE I - NAME

The name of the corporation is Rex Padgett, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually commencing on the date of the execution of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of installing and finishing drywall products.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it offered to others. Any shareholder wishing to sell the outstanding stock he holds, must first offer the shares to the other registered shareholders of the corporation at the price agreed upon in the corporate by-laws.

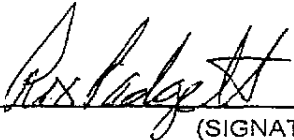
